FBC retains no right of control over ENTITY, nor any employee, agent, servant, subsidiary, representative, officer, shareholder, or any other person, firm, and/or entity acting for or on behalf of ENTITY.

ENTITY has been provided a copy of FBC's Child Protection Policy.

ENTITY assumes full responsibility for the safety of any person, including minors, during the ministry, event and/or organized activity while on FBC premises.

**II. INDEMNIFICATION / HOLD HARMLESS**

ENTITY agrees to indemnify FBC and their respective administrators, successors, assigns, subsidiaries, agents, representatives, officers, employees, shareholders, and all other persons, firms, and/or other corporations acting for or on behalf of FBC from any and all liability, loss, damages, or claims, claims of subrogation and expense specifically arising by reason of medical payments made to any person/s so harmed on FBC's premises during the ministry, event, and/or organized activity.

In the event that any such claims are asserted, ENTITY agrees to assume the defense of such claims, at his/her/their cost, and to hold FBC and their respective administrators, successors, assigns, subsidiaries, agents, representatives, officers, employees, shareholders, and all other persons, firms, and/or other corporations acting for or on behalf of FBC harmless.
